He felt that was more important than sidewalks. Public Works Director, Dana Wardwell, responded that the section of Broadway from Husson Avenue to Griffin Road was part of the MDOT project for next year. Mr. Wardwell also indicated that the City was looking for volunteers to be part of a study group for improved access on that corridor.
