### **Meeting Minutes**

<u>Commissioners Present</u>: Hollie Adams, Kelly Chenot, Nina Earley, Kal Elmore, Tristan Greenlaw, Barbara McDade (via Zoom), Samantha Schipani, Lovern Stockwell

**Others**: Anne Krieg – Director of Development, Sarah Maquillan – Development Assistant

- 1. A quorum being present the April 5, 2024 meeting of the Commission on Cultural Development was called to order by Chair Earley at 8:30 AM.
- 2. Meeting Minutes Motion passed to approve the minutes of the March 1<sup>st</sup> meeting.
- 3. Financial Report No change since last meeting; no questions from Commissioners.
- 4. Committee Reports:
  - a. Grant Committee Chair Adams reported that four applications were received for the spring cycle, and the Committee will be meeting before the Commission's May meeting. Confirmed members of the Committee: Commission Chair Earley and Commissioners Stockwell, Clark, and Schipani. Commissioner Schipani asked about conflicts of interest when reviewing applications Committee Chair Adams and Commission Chair Earley provided clarification.
  - b. Cultural Asset Committee Chair Greenlaw reported that he still needs to speak with City staff regarding access to GIS system for updating storyboards. Will call Committee meeting within the next few months for the biannual asset review. Commission Chair Earley asked about the status of the plaques for the canoe and Paul Bunyan sculptures. Commissioner Schipani asked for a brief summary of this project Commission Chair Earley clarified. Commissioner Stockwell also provided some context regarding the canoe sculpture, and Commissioner McDade provided some context regarding the Paul Bunyan sculpture.
  - c. ARTober No update from Committee Chair Earley; will likely call a Committee meeting after final budget approval. Confirmed members of the Committee: Vice Chair Adams and Commissioners Chenot and Elmore.

### 5. Report of the Chair --

- a. Chair Earley gave overview of requested budget for public art project and meeting with Lisa Sockabasin of WPHW. Earley and Vice Chair Adams researching other funding sources as well, but noted more will be known after final City budget is approved. Discussed Sockabasin's suggestions regarding requests for funding. Commissioner Elmore asked how the artist will be selected Earley responded that it can be Commission discussion, but does think it should be Native artist. Commissioner Stockwell asked about whether specific tribal membership would be requirement of selected artist and whether they are required to be a Bangor resident -- Earley responded that she will ask City if artist could be based elsewhere if primary project team is part of Bangor community. Commissioners discussed further ideas and timelines for requests for funding. Development Director Anne Krieg reported staff will confirm final Commission budget approved when received.
- b. Chair Earley also reported on conversation with program director at Maine Arts Commission.



6. Staff Update – Development Director Krieg reported that the base budget has been submitted, as well as the additional requests discussed at previous meeting. The Budget Committee hearing as not been scheduled yet, but will email Commission with dates/times once scheduled.

### 7. Other Business

- a. Commissioner Chenot gave overview of last Downtown Bangor Partnership board meeting.
- b. Chair Earley asked about the possible public restroom art project Development Director Krieg responded that she will keep Commission updated.
- c. Commissioner Elmore reported that Bangor Beautiful has proposed a new mural Earley noted that this is one of the grant applications for the spring cycle.
- d. Krieg reported that the ground mural project was approved by City Council.

# GRANT APPLICATION

Our Mission is to promote the development of Bangor as a regional arts center that nurtures the artistic and cultural expression of its diverse peoples.

### ELIG BILITY REQUIREMENTS

- Match requirement- Applicants must demonstrate a 1:1 match through other means of fundraising (grants, ticket sales, donations, in-kind, etc.). For example, a request for a \$2,000 grant must demonstrate income equal to or greater than \$2,000.
- Funds requested must be used on **projects located within the City of Bangor** and directly serve the Bangor community.

### Eligibility for Organizations

• Only 501(c)3 Tax Exempt Non-Profits or organizations applying through a 501(c)3 partner are eligible.

### Eligibility for Individuals

- Individual artists may submit applications for grants up to \$1,000.
- Individual artists are only eligible for reimbursement for up to 50% of the costs of supplies and materials.
- Special consideration will be given to projects designed to be displayed in a public location. All works funded must initially be accessible to the public.

# **APPLICATION & GRANT DETAILS**

- Applications are accepted on a bi-annual basis and must be postmarked by April 1<sup>st</sup> or October 1<sup>st</sup> for consideration.
- The Commission reviews applications at the monthly meetings scheduled for May and November.
   The Commission will send their recommendations to the Business & Economic Development
   Committee for approval before going to the Council for final approval.
- Applicants may attend the Commission meeting when grants are considered. They are not expected to make a presentation but may be given the opportunity to speak or answer questions.
- The Bangor City Council gives final approval on all Commission recommendations.
- Eligible applicants that receive a grant may only submit one application per calendar year.
- Applicants that did NOT receive a grant may submit an application at any subsequent grant cycle.
- The decision process on each application will take a minimum of six weeks from the end of the application deadline.
- Projects will not be funded retroactively. Requests should be for funds needed after June 1 for the spring cycle and after December 1 for the fall cycle.
- Funds granted must be used within 12 months, other than for exceptional conditions, in which a request for extension must be submitted.
- A final report is required of all successful grant recipients, detailing how funds were used and the impact

We would like to request \$5,000.00 in funding so we can continue to keep ticket prices accessible for all members of the community and so we may continue our support for other Artistic businesses within the Bangor community. This funding will alleviate our administration costs at Thomas School of dance and venue costs at Gracie Theatre, both in Bangor. Opening that funding will allow us to purchase new costumes to make all dancers no matter their body type feel confident and proud while preforming on stage. The majority of our costumes are over 20+ years old. This grant will help alleviate our basic production costs and help to make our company more inclusive and representative of our entire community and all of its members.

# Commission on Cultural Development- City of Bangor Grant Proposal

The Bangor Ballet Company would like to request a grant award of Five-Thousand-Dollars (\$5,000.00) to help alleviate production and administrative costs for our 2024 production of "Nutcracker in a Nutshell," traditionally performed in early December at the Gracie Theatre in Bangor. Our total income in ticket sales for our 2023 Bangor Productions was \$10,400.00. As the cost of living and production becomes higher, we have seen our sponsorships and corporate donations drastically decline.

A grant award of Five-Thousand-Dollars will allow us to keep our ticket prices accessible to all members of the community (\$16.00 for adults, \$10.00 for students and seniors). It will also allow us to alleviate production and administrative costs four our costume shop and studio spaces located at Thomas School of Dance in Bangor, Maine. This will allow the company to allocate funding we would otherwise not have in order to purchase new, inclusive costumes for our twenty five plus members. With this funding we can hire local seamstresses to make costumes that will showcase all of our dancers as eloquently and as confidently as they should be. We can design platter tutus that can be adjusted and altered based on each individual dancer, and not have to tell a company member that because they weigh over one hundred pounds, our performance platters, (which is a moment of triumph for any ballet dancers) do not fit thembecause that is unacceptable. We will also be able to buy the proper storage for our costumes, ensuring they can last for generations. We can continue to support Thomas School of Dance with our rental income, as they have supported us in every way they can.

Bangor Ballet, originally established as a youth ballet company in 1990, evolved into a pre professional ballet company in 2010. The youth costumes we have are too small to promote inclusitivity and positive body image within the company or the community. Our costumes are over twenty five years old, outdated, and literally collapsing at the seams. Our inherited costumes are not only aged and worn, they are youth sizes. The majority will not fit anyone over 110 pounds. We have tried our best, but with the age of the costumes our best simply is no longer good enough

Pre made platter tutus, are not manufactured above a women's size 6 and cost between Four-Hundred and Five-Hundred dollars. Custom platter tutus can go up into the thousands. We have found local seamstresses willing to make them for our organization out of practice platters (which will have elastic waste bands, and interchangeable tops) which are able to be altered or changed based on the dancers body type. The estimated cost of out costume replacements and adequate storage is \$5,000.00, which will include variable pieces that can fit multiple body types. All tutus and costumes will be completed by November 2024, to be used in our 2024 productions of Nutcracker in a Nutshell.

Every dancer, has dedicated themselves to the same art from. They have put in the same hours, the same lessons, the same time. They have given up so much in their young lives because they

were focused on something bigger. Vaganoava (classical Russian ballet) training is not for the week of heart. It requires kids to make their dedication to classical training at the age of seven, without any instant gratification or rewards. Pointe work alone takes a minimum of two years, after an average of four years of technique work. After all of that dedication, their moments on stage should all be a breathtaking as possible.

For most, ballet will end after high school. Their time with the Bangor Ballet Company is their moment. It is their time to shine, and they deserve to look back and see the grandness and importance of their commitments and efforts.

While the climate of ballet has somewhat changed, society has not. In fact the affects of social media, and 'always perfect" influencers and highly edited images are more prevalent than ever. That influence tells not just children and adults, that they are not good enough because they don't meet the impossible standard set by someone who sits behind a computer.

Preforming arts is where we can change this. Not only can we show different body types, different nationalities- but on stage we have the opportunity to celebrate them. No one should feel like there is no place within the ballet community. Members of our company should not feel less included or celebrated because we don't have access to the costumes they deserve. It matters not only to them but to the community.

Our organization will not be able to do this without the City Of Bangor's assistance. We thank you for your time and consideration.

# **Proposal Narrative for Bangor Beautiful Spring Woods Mural**

With support from a Bangor Commission on Cultural Development grant, Bangor Beautiful will commission a colorful two-story mural on the side of 116 Hammond Street in downtown Bangor by Maine-based artist Jared Goulette. The mural will depict the Maine woods in springtime. The impact of this project will support community wellness and appreciation for the arts and nature among the visitors and residents of Bangor. This mural will also beautify an urban area, increase pedestrian safety, provide education about the natural environment, and elevate Bangor's public art.

The project will beautify an unremarkable brick wall visible in the heart of Bangor into a captivating and colorful piece of public art. The mural will be part of a concentrated beautification blitz by our organization on Hammond Street. A large ground mural being installed in May and the planting of over a dozen native street trees in April will complement the project.

This mural will benefit residents and visitors to downtown Bangor since its location is in close proximity to restaurants, stores, and services. The location of the mural on Hammond Street (U.S. Route 2) is a primary pedestrian and vehicle route connecting the west side of Bangor and much of Bangor's subsidized housing to downtown Bangor. It is in close proximity to vital community resources such as the Penobscot County Jail and US Post Office as well as restaurants and businesses. The mural's prime location means it will be viewed by the full socio-economic spectrum of Bangor.

Community wellness will benefit from exposing downtown's many daily visitors to the beauty and nature of the mural. The planned events to celebrate the mural will be free and open to the public. Natural experiences are associated with mental and physical benefits like better moods, less anxiety, and positive social interactions. Public art has positive benefits for a community, such as improving quality of life and advancing equity.

Also, pedestrian safety will be increased by helping to calm traffic traveling on Route 2, as people slow to view the mural or are encouraged to visit the mural on foot. This will increase safety for pedestrians and all vulnerable road users.

Providing visual education about Maine's natural environment, the mural will depict the Maine forest floor in spring, including a vernal pool and plants such as fiddleheads, a local native food source. Flora and fauna depicted will be native to Maine, helping to connect people to the natural ecosystem local to our area, while teaching them about their environment. As part of this project, we will host an Educational Nature Walk along the nearby Kenduskeag Stream Trail led by a biologist from the University of Maine.

Bangor's public art portfolio is relatively new with the oldest public mural being just over ten years old and most murals have been painted by local artists in similar styles. This style of mural does not currently exist in Bangor, so this project will stand out among current murals and help extend the boundaries of public art in Bangor. Jared Goulette uses a vibrant color palette of premium spray paint to create his artwork and often showcases a multitude of shadowing, highlight effects and more to push the dimension and realism of his paintings, murals, and digital designs.

Following the completion of the mural, we will organize a community celebration event and artist talk at the mural's location. The mural's beautiful depiction of nature in an otherwise stark urban space, combined with our Educational Nature Walk and Celebration & Artist Talk, will help raise awareness of and appreciation for our natural world as well as for public art.

### **Bangor Cultural Commission Narrative**

<u>Proposed use of requested funds</u>: Funding will be used to create greater access to high-quality music education for Bangor youth through extracurricular music instruction during the school year, rock camps in July and August, and at least two community performances (October and March).

<u>Targeted population:</u> The Amplify Bangor program primarily serves people ages 8 to 18, with a target population of those struggling at home or in school due to language, cultural, social, learning, and/or income barriers. Our distinctive focus on modern music enables us to provide an alternative for young people who need music in their lives but may resist participating in more traditional music programs and out-of-school activities. We provide programs that offer a constructive, creative outlet that speaks to student passions while building their musical skills, confidence, friendships, and community connections.

<u>Desired outcomes:</u> The goal of this program is to have more young people in Bangor experience the benefit of music education and share those benefits with the community. We would like to increase the number of teen bands in our program by 20% this year and see the same increase in summer camp participation. We would also like to offer three community performances, Girls Rock! Bangor in March, BanGORE in October, and an additional concert TBD. Measurable benefits for those participating in the program include:

- (1) Music and performance skills: 90% of those served will build their music skills and successfully apply them with other students. At least 75% will perform in at least one community concert.
- (2) Engagement: Students will become engaged in a positive and supportive program. At least 75% of those who participate will continue music engagement through other program offerings.
- 3) Personal/social growth: At least 75% will report that participating in MAMM has increased their confidence, improved their ability to work as part of a team, and/or reduced social isolation.

Plans for assessing progress toward goals: The program's impact will be gauged using satisfaction surveys, attendance and retention tracking, music instructor reports, and student questionnaires. MAMM will also solicit regular feedback from its partners to ensure that it is developing and implementing programming that meets community needs. Questions on the participant surveys will include queries such as: Did this experience raise aspirations to pursue music academically or as a career? Did the experience positively impact relationships with peers, parents, or teachers? Did it strengthen leadership skills? Was the experience fun?

Feedback from program participants has been consistently positive and indicates that it is successful in enhancing performance skills, student engagement, and pro-social outcomes. We are always looking at ways to make improvements to the program, but believe that Amplify Bangor will be successful in achieving our desired outcomes.

<u>Other sources of support:</u> MAMM has received support from The Onion Foundation, Morton Kelly Charitable Trust, Widgeon Point, and Bangor Savings Bank.

<u>Projected timeline for use of funds:</u> Optimally, an Amplify program has a timeline that aligns with a school calendar. However this is not necessary for a successful program which can be started/concluded at whatever time best suits the partnership. In this case, fund use would start in July for support for music summer camps participation and then from September to June to support after school music education programming.

Amplify Bangor offers music education at no cost to participants in a way that *amplifies* the programs of other community organizations. It is tailored to reach under-resourced populations and those facing barriers. Our Primary partner will be Bangor Parks and Rec, although other partnerships are being explored. The program is composed of three key elements:

**1- Development and Execution of Collaborative Programs:** Collaborate with schools and community organizations to amplify the benefits of their services through music education at no cost to participants.

Accessibility to music education contributes to the overall well-being of young people by nurturing their creativity, cognitive skills, emotional expression, and sense of belonging. Collaborating with Amplify allows service organizations to diversify their offerings with music, thereby broadening their reach, relevance, and impact.

**2- Management of Community Performances:** Provide student musicians the opportunity to showcase their talents through MAMM events and community performances.

Potential financial assistance through the city of Bangor Commission on Cultural Development would make possible one evening in late July designed to commemorate the 'Old YMCA' site at 127 Hammond St.

This proposal is inspired through my current artistic research into the site as an emblem of a social system and change within communities. Since February and through conversations over the phone and with coffee, I have been granted permission by Alloy Contracting to document the demolition of the site as well as make work on-site during demolition. The culminating works will be a part of my MFA thesis exhibit in May. While the thesis exhibit showcases my work as an artist, it can't begin to totally address the vast amount of information from current residents- memories, questions, concerns, opinions, that are far larger than the University of Maine Campus can engage with. Therefore, I am seeking funding to invite the community into an experiential vigil that could commemorate all that this site stood for.

An opportunity to gather as a community to honor the memories as well as grief in loss of local architecture is something not often seen in the public. Often folks engage in this process in isolation. The opportunity to hold vigil for a site that so many grew up in is incredibly valuable. Gathering power within a community strengthens the threads of civic engagement and a sense of connectivity- something that every community is in need of. The arts can be a potent container through which conversation and connection can occur. It is with this in mind that I seek support to host a pop-up art exhibit and storytelling evening.

Any and all residents of Bangor are encouraged to attend, though the image content will be from folks with memories of the YMCA. Anyone living in Bangor who would be interested in sharing their experiences while watching the urban landscape change, and those who wish to express their visions for the future of the site are also encouraged to attend.

The project timeline begins late June and ends with the exhibit date itself (sometime in late July). Already, many informal interviews and documentation have been collected through individual artistic research. Conversations with community members over Facebook groups, and on-site have prompted considering how best to share audio and video transcripts and how in late June it will be possible to conduct more formal interviews.

Funding would purchase materials to construct temporary columns and cubes large enough to project images on all sides. Content would include the site as a YMCA in the 1800's, the site currently and images sourced from the community through facebook, craigslist, the count administration, the library and additional promotional channels. The in-kind match consists entirely of donated materials and equipment as well as volunteer and artist time slated at \$28/hr based on the federal rate.

Pending LOS from the Penobscot County Commissioners, Bangor Public Library. Bangor Historical Society and community members. Pending partnership with Lights Out Gallery and the University of Maine Intermedia Department for equipment rental.

It would be a great honor to work with both the county and the city on an aesthetic

community-centric project designed to celebrate how neighborhoods can respond and enact change.
