RESIDENTIAL REBATE PROGRAM

The EnergySmart Bangor Residential Rebate Program offers additional savings for Bangor residents of owner-occupied homes that qualify for the Efficiency Maine Home Energy Savings Program.

Here's how it works:

WHO QUALIFIES

The EnergySmart Bangor Residential Rebate Program is open to all Bangor residents of owner-occupied, residential properties in the City of Bangor. All work must comply with Efficiency Maine's Home Energy Savings Program (HESP) terms and conditions (on pages 3 & 4 of Efficiency Maine HESP claim form).

STEP 1

OBTAIN A QUOTE FROM AN EFFICIENCY MAINE REGISTERED VENDOR

The selection of a vendor is the responsibility of the customer. A list of Efficiency Maine Registered Vendors is available online at: www.energysmartbangor.com/at-home/vendor-locator.

STEP 2

APPLY FOR A REBATE RESERVATION NUMBER FROM THE CITY

To apply for a rebate reservation number, you must do one of the following:

- E-Mail energysmartbangor@bangormaine.gov;
- Call: 207-992-4284 and leave a message with the project description, location, project quoted price and a return phone number.

Rebate reservation numbers expire after 90 days, so do not apply for a number too far in advance of planned work.

STEP 3

PERFORM WORK AND KEEP RECEIPTS FROM REGISTERED VENDOR

All receipts should be paid, itemized and submitted with rebate forms in order to qualify for rebates.

STEP 4

SUBMIT REBATE FORMS TO EFFICIENCY MAINE FOR REIMBURSEMENT

Efficiency Maine will require both the completed EnergySmart Bangor Rebate Request Form AND Efficiency Maine's Home Energy Savings Program Form along with the paid, itemized receipts in order to process rebates. Please allow 6 weeks for rebate processing from Efficiency Maine. Rebates will be combined.

Please note: A rebate reservation number is *required* in order to receive a rebate from the EnergySmart Bangor Residential Rebate Program. We encourage you to apply for this number as soon as possible, but not more than 90 days in advance of completion of work. Rebates are only available while funds last and will be provided on a first-come first-serve basis. Rebate reservation numbers expire after 90 days. To apply for a rebate reservation number, please call 992-4284 or E-Mail energysmartbangor@bangormaine.gov. When requesting a rebate reservation number, please provide your name, the physical address where the energy improvements are to take place, a brief description of the project and the quoted price from the Efficiency Maine Registered Vendor.

All work must comply with Efficiency Maine’s Program Terms and Conditions (pages 3 and 4 of Efficiency Maine HESP Claim Form). Please allow six weeks for rebate processing. Rebates will be combined.
