APPENDIX L. List of Organizations Presented To

Following is a description of the organizations whom staff met with during the study timeframe. Staff felt these organizations represented many key community leaders who would offer valuable feedback, and whose business or organization would be greatly affected by a stormwater utility if it were adopted. Each of the organizations were met with, face to face, by appointment or through public meetings and familiarized with the Stormwater Utility Feasibility Study. Responses from our meetings were overwhelmingly supportive of the stormwater utility concept vs. the "do nothing" and the "increase taxes" options.

- Rotary International Club of Bangor A service organization made up of community leaders whose mission is to provide service to others, promote integrity, and advance world understanding, goodwill, and peace through its fellowship of business, professional, and community leaders.
- Fusion Bangor An organization of Chamber of Commerce members that are young professionals (age 19-40) that promote networking, activism, and community service among Greater Bangor residents.
