The City of Bangor requests bids to furnish and deliver LED streetlight fixtures, including bulbs, to the Public Works Department, 531 Maine Avenue, Bangor, ME for a period of three (3) years. An option to renew for an additional three (3) years is contemplated upon mutual agreement of both parties.

II. General Information

By submitting a response to this solicitation, the bidder accepts the responsibility for downloading, reading and bidding by the terms and conditions set forth in the City's "General Information for Vendors".

III. Submission

To be considered, return page three of this Request for Bids, and any other relevant or requested information, in an envelope clearly marked "**Bid No.: B16-024: LED Streetlight Fixtures**" by **2:00 PM, Wednesday, March 30, 2016** to the Purchasing Department, City Hall, 73 Harlow Street, Bangor, Maine 04401.

Bids may also be submitted via email by using the link at the top of this page or by sending to: bids@bangormaine.gov. If emailing bid, please reference "**Bid No.: B16-024: LED Streetlight Fixtures**" in the subject line. Bids will be publicly opened at the time stated above.

A tabulation of all bids received will be available after 3:00 PM on the date of opening. Bid results may be viewed by visiting the City's website at www.bangormaine.gov/bidtabs.

IV. Questions

Any questions must be directed in writing to bids@bangormaine.gov no later than **4:30 PM, Friday, March 18, 2016**.

The City will issue a response to any questions or inquiries submitted in writing by the date above, on or before **4:30 PM, Monday, March 21, 2016**. The response will be in the form of an addendum, which will be available on the City's website.

Any addenda must be acknowledged and included with the proposal submission. All signatures on offers, amendments, or related correspondence must be by persons who are authorized to contractually bind the offerors.

V. Award

The bid award will be based on one or more of the following:

- Price of the equipment offered
- Quality and performance of the equipment offered
- Availability of the equipment
- Prior history or experience with the Bidder, and prior history or experience with the equipment offered

VI. Information for Bidders

1. All Federal and State taxes must be excluded from the bid price. A tax exemption certificate for the City of Bangor shall be furnished to the successful Bidder upon request.
2. A complete Manufacturer's brochure must be included.
3. Any exception to the provisions in the specifications must be itemized on a separate page titled "Exceptions" with a detailed explanation of the exception.
4. All equipment must be thoroughly inspected, serviced and ready for use upon delivery.

VII. Specifications

A. Description & Quality Assurance:

Acceptable Manufacturers Cree LED streetlight fixture including lamp part number BXSP-B-HT-2ME-A-57K-UL-SV-R or approved equivalent

B. Delivery:

All materials shall be delivered to 530 Maine Avenue Bangor, Maine 04401 and handled in accordance with manufacturer's written recommendations.

C. Quantities:

Will vary depending on need. Minimum order is expected to 80 per year.
